

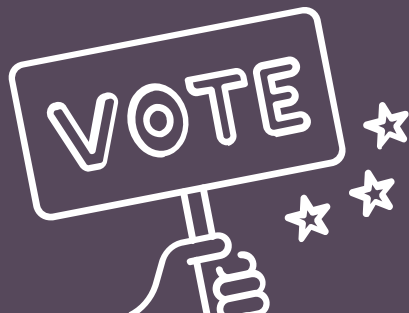

KNOW YOUR VOTING RIGHTS

Can I register to vote?

Yes, if...

- ✓ You are a United States citizen
- ✓ You are a Tennessee resident
- ✓ You are 18 or older
- ✓ A court has not removed your voting rights

When can I register to vote?

You can register at **ANY** time!

***BUT** your registration must be completed
and submitted at least 30 days before
voting in an election.

VOTING BASICS: WHAT TO KNOW WHEN VOTING

WHEN can I vote?

1. **On Election Day** **use the QR code to access dates.*
2. **During Early Voting** (before Election Day) **Your local election commission office can tell you where you can early vote. This can be also accessed thru the QR code.*

WHAT do I need to bring to vote?

A photo ID issued by Tennessee or the federal government.

WHERE can I vote?

Your polling place should be listed on your voter registration card.

**If your polling place is not listed, contact your local county election commission.*

WHAT if I need help to vote?

You can choose someone to help you with voting or ask a poll worker to help you.
